Please ensure that the application is fully and legibly completed with all details noted as required.

EXPLANATION OF Vendor Class

Class A - (Fast food - hamburgers, fries)

This Class is for full service food vendors, chip trucks, Ethnic foods etc. Hot Dog Carts are prohibited during Quarry Days.

The sale of Candy Apples and Hot Dogs is prohibited.

Class B - (Snack foods - donuts, ice-cream, candies, fruits, etc.)

This class includes any vendor selling specific food items. Hot Dog Carts are prohibited during Quarry Days.

The sale of Candy Apples and Hot Dogs is prohibited.

Class C - Non food vendors (jewelry, trinkets, sunglasses etc.)

This class includes any Vendor selling any wares other than food. Please be sure to list all items that you sell/ service you provide. You will ONLY be permitted to offer what you have listed.

We do our best to situate you so that you are not located next to someone offering the same product/service. We cannot do this if you do not detail your product/service. We reserve the right to limit the number of Vendors offering the same product/services.

Class D - Non Profit (information & fundraising)

This class is specifically for those fundraising, advertising, and showcasing. The only items a Class D vendor can sell are tickets for a draw or specific items for fundraising. This information MUST be detailed on the Vendor Application Form.

Class E – Local Business

To be in this class you **MUST** be a Stonewall COMMERCIAL RETAIL business OR Stonewall home based business with a Development Permit issued by South Interlake Planning District

If you are a Main Street Business, and are planning on setting up anywhere other than in front of your business, you **MUST** detail this information. We will try and accommodate those who wish to set up on the street outside their business however due to street setup this is not always possible.

Please Note: Contact information **MUST BE PRINTED CLEARLY**. Often, we cannot read phone numbers or email addresses on the forms. This will only delay confirmation of your acceptance.

If you have an email address, please provide it to us. This is our best mode of communication.

Please be aware that all cheques will be deposited on receipt. This in no way guarantees your acceptance. If your application is denied, a cheque, in the full amount, will be sent to you as quickly as possible. **If your application is denied, the decision is final.** However, you may make application for the following year.

Vendors that require power/water will be given priority regarding location based on availability.

If you are **not** planning to be in attendance from Friday noon – Sunday 4pm, please make us aware. This will play a large part in where you will be located.

Vendors may set up between **12pm – 3pm** on the Friday. You **MUST** report to the Information Booth prior to set up. Please note that parking is limited and there will be no vehicular access to Main Street after 3:00 pm on Friday.
