

**TOWN OF STONEWALL  
BY-LAW NO. 14/05**

Being a by-law of the Town of Stonewall to amend By-law No. 3/03 being the Cemetery By-law, by the provision of a Cemetery Plot Fee for persons who are non-residents or do not own property within the Town and by the provision of an increase to the fee for a second burial in a plot.

**WHEREAS** By-law No. 3/03 of the Town of Stonewall regulates the Stonewall Cemetery.

**AND WHEREAS** the Council of the Town of Stonewall deems it to be expedient and equitable to provide for a cemetery plot fee specifically for persons who are neither residents nor property owners within the Town of Stonewall at the time of purchase of the cemetery plot.

**AND WHEREAS** the Council of the Town of Stonewall further deems it to be expedient and equitable to increase the fee for a second burial in a plot.

**NOW THEREFORE** the Council of the Town of Stonewall, in Council duly assembled, does hereby enact as follows:

1. THAT Section 3. a) of By-law No. 3/03 be hereby amended to read as follows:
  3. a)i) THAT the cost of a plot in said Cemetery shall be FIVE HUNDRED DOLLARS (\$500.00) each for a **resident** of the Town or a **person who owns property** within the Town at the time of the purchase of the said plot. No owner of a plot in said Cemetery shall transfer said plot without the written permission of the Town having been first obtained and in addition, said plot cannot be sold for more than the amount at which said plot was purchased from the Town.
  - ii) THAT the cost of a plot in said Cemetery shall be ONE THOUSAND DOLLARS (\$1,000.00) each for a **non-resident** of the Town or a **person who does not own property** within the Town at the time of the purchase of the said plot. No owner of a plot in said Cemetery shall transfer said plot without the written permission of the Town having been first obtained and in addition, said plot cannot be sold for more than the amount at which said plot was purchased from the Town.
2. THAT Section 4. b) ii) of By-law No. 3/03 be hereby amended to read as follows:
  4. b)ii) The fee for the second burial of either a human body or ashes in a plot owned by a **resident** of the Town or by a **person who owns property** within the Town shall be TWO HUNDRED AND FIFTY DOLLARS (\$250.00). There shall be no cost for the third and/or fourth burial in a plot subject to the maximum number of burials in a plot as prescribed in Section 4.a).
  - iii)The fee for the second burial of either a human body or ashes in a plot owned by a **non-resident** of the Town or by a **person who does not own property** within the Town shall be FIVE HUNDRED FIFTY DOLLARS (\$500.00). There shall be no cost for the third and/or fourth burial in a plot subject to the maximum number of burials in a plot as prescribed in Section 4.a).
3. THIS By-law shall come into force and take effect of the 1st day of January, A.D., 2006.
