Pursuant to Section 6(3) of By-law No. 11-19 your Application will be considered by Council at a regularly scheduled meeting. You shall be notified of the meeting, date, time and location. In addition, the Town will be contacting all property owners within a 100 meter radius of the premises of the proposed excess animal application to inform them of the application and the date, time and location of the meeting at which Council shall consider the application.

In determining whether or not to grant an excess animal permit to an applicant and/or to determine what conditions the excess animal permit shall be subject to; the Council shall review all relevant factors and without limiting the generality of the foregoing the following factors shall be considered:

- (a) the proposed maximum number of dogs and/or cats to be kept on the premises;
- (b) if the number of dogs and/or cats meets or exceeds the number prescribed by Regulation under The Animal Care Act S.M. 1996. c.
   69 the applicant must possess or be in the process of applying for a Provincial Kennel License issued through the office of the Provincial Veterinary;
- (c) the intended purpose for keeping the dogs and/or cats on the premises;
- (d) the steps which have been taken to ensure that the dogs and/or cats will be adequately and safely housed;
- (e) the steps which have been taken to ensure that disturbances to neighbours from excessive noise, odour, waste disposal and any other potential nuisances are avoided;
- (f) any inspection report from the Animal Control Officer or the Poundkeeper as may be requested by the Council;
- (g) any inspection report from the public health authorities or any other authorities as may be requested by the Council;
- (h) any representations made by the owner or on behalf of the owner either in writing or at the meeting of Council where the application for an excess animal permit will be heard; and
- (i) any representations made by neighbours of the owner or any other interested party, whether in writing or by oral submission at the meeting of Council at which the application for an excess animal permit is heard.

An Excess Animal Permit **if issued** is only valid for a period of one year from the date of issuance. An Excess Animal Permit may be renewed subject to the submission of this Application **30 days prior to the expiry** of the Permit.
